### OVERSIGHT BOARD CONFIRMS FIFTH MEETING AND ANNOUNCES AGENDA

*(San Juan, PR – March 7, 2017)* – The Financial Oversight and Management Board for Puerto Rico (the “Oversight Board”) created under the bipartisan Puerto Rico Oversight, Management and Economic Stability Act (“PROMESA” or the “Act”) confirmed today that they will hold their fifth public meeting in New York City on Monday, March 13, 2017 at 9:00 a.m. EST.

The meeting will be held at the Auditorium, Level B of the Alexander Hamilton Federal Building located at One Bowling Green, New York, New York 10004.
