



## **Instructions and Registration Form to Participate in the Financial Oversight and Management Board for Puerto Rico Public Meeting**

The Financial Oversight and Management Board for Puerto Rico (the "Oversight Board") created under the bipartisan Puerto Rico Oversight, Management and Economic Stability Act ("PROMESA" or the "Act") will hold a public meeting in New York, next **Monday, March 13, 2017**. The meeting will take place at the Alexander Hamilton Federal Building, Auditorium, Level B, located on One Bowling Green, New York, NY, starting at **9:00 AM EST**.

This meeting will be open to the public following this registration protocol, established in order to manage meeting room seating capacity measures.

### **Registration Protocol:**

1. Those interested in attending must complete the pre-registration form, available at the Board's website: [www.oversightboard.pr.gov](http://www.oversightboard.pr.gov) and must return it via email to [comments@oversightboard.pr.gov](mailto:comments@oversightboard.pr.gov) by **Thursday, March 9, 2017 at 12 noon**. Incomplete forms will not be considered.
2. Available spaces will be distributed based on the order in which the emails are received and up to the maximum seating capacity, upon which pre-registration will close. Pre-registration will be confirmed via an email notification to the same address used for pre-registration.
3. On the day of the meeting, individuals who have been pre-registered are asked to present themselves at the registration table located in the building right side entrance, identified as "National Museum of the American Indian Group Entrance" and present a valid identification (valid driving license or passport).
4. After passing through the check point, registered participants will continue on to the meeting room where the working session will take place.

### **Additional Observations:**

1. Registration and attendance to the meeting is non-transferable.
2. No bags, backpacks, briefcases, or purses will be allowed in the room.

3. Attendees must be willing to comply with a metal registration protocol to access the meeting room.
